What does this policy affect?

- 1 This policy affects the delivery of subjects of reformed GCE and GCSE qualifications which contain a component(s) of non-examination assessment.
- 2 “The regulator’s definition of an examination is very narrow. In effect any type of assessment that is not ‘externally set and taken by candidates at the same time under controlled conditions’ is classified as non-examination assessment (NEA). ‘NEA’ therefore includes, but is not limited to, internal assessment. Externally marked and/or externally set practical examinations taken at different times across centres are classified as ‘NEA’.”

Purpose of the policy

- 3 The purpose of this policy, as defined by the Joint Council for Qualifications (JCQ), is to
 - cover procedures for planning and managing non-examination assessments
 - define staff roles and responsibilities with respect to non-examination assessments
 - manage risks associated with non-examination assessments

What are non-examination assessments?

- 4 “Non-examination assessments measure subject-specific knowledge and skills that cannot be tested by timed written papers.
- 5 There are three assessment stages and rules which apply to each stage. These rules often vary across subjects. The stages are:
 - task setting;
 - task taking;
 - task marking.”

Procedures for planning and managing non-examination assessments identifying staff roles and responsibilities

The basic principles

Head of centre

- 6 Ensures that the centre’s *non-examination assessment policy* is fit for purpose
- 7 Ensures the centre’s *internal appeals procedures* clearly detail the procedure to be followed by candidates (or their parents/carers) appealing against internal assessment decisions (centre assessed marks) and requesting a review of the centre’s marking

Senior leaders

- 8 Ensure the correct conduct of non-examination assessments (including endorsements) comply with NEA and awarding body subject-specific instructions
- 9 Ensure the centre-wide calendar records assessment schedules by the start of the academic year

Quality assurance (QA) lead/Lead internal verifier

- 10 Confirms with subject heads that appropriate awarding body forms and templates for nonexamination assessments (including endorsements) are used by teachers and candidates
- 11 Ensures appropriate procedures are in place to internally standardise/verify the marks awarded by subject teachers in line with awarding body criteria
- 12 Ensures appropriate centre-devised templates are provided to capture/record relevant information given to candidates by subject teachers
- 13 Ensures appropriate centre-devised templates are provided to capture/record relevant information is received and understood by candidates
- 14 Where not provided by the awarding body, ensures a centre-devised template is provided for candidates to keep a detailed record of their own research, planning, resources etc.

Subject head/lead

- 15 Ensures subject teachers understand their role and responsibilities within the non-examination assessment process
- 16 Ensures NEA and relevant awarding body subject specific instructions are followed in relation to the conduct of non-examination assessments (including endorsements)
- 17 Works with the QA lead/Lead internal verifier to ensure appropriate procedures are followed to standardise internally/verify the marks awarded by subject teachers
- 18 Understands the arrangements that the centre needs to put in place where the centre might accept private candidates (including distance learners and home educated students) for components of non-examination assessment

Subject teacher

- 19 Understands and complies with the general instructions as detailed in NEA
- 20 Where these may also be provided by the awarding body, understands and complies with the awarding body's specification for conducting non-examination assessments, including any subject specific instructions, teachers' notes or additional information on the awarding body's website
- 21 Marks internally assessed work to the criteria provided by the awarding body
- 22 Ensures the exams officer is provided with relevant entry codes for subjects (whether the entry for the internally assessed component forms part of the overall entry code or is made as a separate unit entry code) to the internal deadline for entries

Exams officer

- 23 Signposts the annually updated JCQ publication *Instructions for conducting nonexamination assessments* to relevant centre staff
- 24 Carries out tasks where these may be applicable to the role in supporting the administration/management of non-examination assessment

Task setting

Subject teacher

- 25 Selects tasks from a choice provided by the awarding body OR designs tasks where this is permitted by criteria set out within the subject specification
- 26 Makes candidates aware of the criteria used to assess their work

Issuing of tasks Subject teacher

- 27 Determines when set tasks are issued by the awarding body
- 28 Identifies date(s) when tasks should be taken by candidates
- 29 Accesses set tasks in sufficient time to allow planning, resourcing and teaching and ensures that materials are stored securely at all times
- 30 Ensures requirements for legacy specification tasks and new specification tasks are distinguished between

Task taking Supervision

Subject teacher

- 31 Checks the awarding body's subject-specific requirements ensuring candidates take tasks under the required conditions and supervision arrangements
- 32 Ensures there is sufficient supervision to enable the work of a candidate to be authenticated
- 33 Ensures there is sufficient supervision to ensure the work a candidate submits is their own
- 34 Where candidates may work in groups, keeps a record of each candidate's contribution
- 35 Ensures candidates are aware of the JCQ documents [Information for candidates - non-examination assessments](#) and [Information for candidates - Social Media](#)
- 36 Ensures candidates understand and comply with the regulations in relevant JCQ documents *Information for candidates*

Advice and feedback

Subject teacher

- 37 As relevant to the subject/component, advises candidates on relevant aspects before candidates begin working on a task
- 38 When reviewing candidates' work, unless prohibited by the specification, provides oral and written advice at a general level to candidates
- 39 Allows candidates to revise and re-draft work after advice has been given at a general level
- 40 Records any assistance given beyond general advice and takes it into account in the marking or submits it to the external examiner

41 Ensures when work has been assessed, candidates are not allowed to revise it

Resources

Subject teacher

42 Refers to the awarding body's specification and/or associated documentation to determine if candidates have restricted/unrestricted access to resources when planning and researching their tasks

43 Ensures conditions for any formally supervised sessions are known and put in place

44 Ensures conditions for any formally supervised sessions are understood and followed by candidates

45 Ensures candidates understand that they are not allowed to introduce improved notes or new resources between formally supervised sessions

46 Ensures that where appropriate to include references, candidates keep a detailed record of their own research, planning, resources etc.

Word and time limits

Subject teacher

47 Refers to the awarding body's specification to determine where word and time limits apply/are mandatory

Collaboration and group work

Subject teacher

48 Unless stated otherwise in the awarding body's specification, and where appropriate, allows candidates to collaborate when carrying out research and preparatory work

49 Ensures that it is possible to attribute assessable outcomes to individual candidates

50 Ensures that where an assignment requires written work to be produced, each candidate writes up their own account of the assignment

51 Assesses the work of each candidate individually

Authentication procedures

Subject teacher

52 Where required by the awarding body's specification ensures candidates sign a declaration confirming the work they submit for final assessment is their own unaided work signs the teacher declaration of authentication confirming the requirements have been met

53 Keeps signed candidate declarations on file until the deadline for enquiries about results has passed or until any appeal, malpractice or other results enquiry has been completed, whichever is later

54 Provides signed candidate declarations where these may be requested by a JCQ Centre Inspector

55 Where there may be doubt about the authenticity of the work of a candidate or if malpractice is suspected, follows the authentication procedures and malpractice information in NEA and informs the exams officer

Presentation of work

Subject teacher

- 56 Obtains informed consent at the beginning of the course from parents/carers if videos or photographs/images of candidates will be included as evidence of participation or contribution
- 57 Instructs candidates to present work as detailed in NEA unless the awarding body's specification gives different subject-specific instructions
- 58 Instructs candidates to add their candidate number, centre number and the component code of the assessment as a header/footer on each page of their work

Keeping materials secure

Subject teacher

- 59 When work is being undertaken by candidates under formal supervision, ensures work is securely stored between sessions (if more than one session)
- 60 When work is submitted by candidates for final assessment, ensures work is securely stored
- 61 Follows secure storage instructions as defined in [NEA 4.8](#)
- 62 Takes sensible precautions when work is taken home for marking
- 63 Stores internally assessed work, including the sample returned after awarding body moderation, securely until the closing date for enquiries about results or until the outcome of an enquiry or any subsequent appeal has been conveyed to the centre
- 64 Reminds candidates of the need to keep their own work secure at all times and not share completed or partially completed work on-line, on social media or through any other means
- 65 Liaises with the IT Manager to ensure that appropriate arrangements are in place to restrict access between sessions to candidates' work where work is stored electronically

IT Manager

- 66 Ensures appropriate arrangements are in place to restrict access between sessions to candidates' work where work is stored electronically.

Task marking –externally assessed components

Conduct of externally assessed work

Subject teacher

- 67 Liaises with the exams officer regarding arrangements for the conduct of any externally assessed non-examination component of a specification
- 68 Liaises with the Visiting Examiner where this may be applicable to any externally assessed component

Exams officer

- 69 Arranges timetabling, rooming and invigilation where this is applicable to any externally assessed non-examination component of a specification

- 70 Conducts the externally assessed component within the window specified by the awarding body
- 71 Conducts the externally assessed component according to the JCQ publication [Instructions for conducting examinations](#)

Submission of work

Subject teacher

- 72 Provides the attendance register to a Visiting Examiner
- 73 Where candidates' work must be despatched to an awarding body's examiner, ensures the completed attendance register accompanies the work, along with student and centre declaration when required.
- 74 Packages the work as required by the awarding body and attaches the examiner address label
- 75 Gives the package to the exams officer for dispatch to the awarding body

Exams officer

- 76 Provides the attendance register to the subject teacher where the component may be assessed by a Visiting Examiner
- 77 Ensures the awarding body's attendance register for any externally assessed component is completed correctly to show candidates who are present and any who may be absent
- 78 Despatches the work to the awarding body
- 79 Keeps a copy of the attendance register until after the deadline for enquiries about results for the exam series

Task marking– internally assessed components

Marking and annotation

Subject teacher

- 80 Attends awarding body training as required to ensure familiarity with the mark scheme/marketing process
- 81 Marks candidates' work in accordance with the marking criteria provided by the awarding body
- 82 Annotates candidates' work as required to facilitate internal standardisation of marking and enable external moderation to check that marking is in line with the assessment criteria
- 83 Informs candidates of their marks which could be subject to change by the awarding body moderation process
- 84 Ensures candidates are informed of the timescale indicated in the centre's *internal appeals procedure* to enable an internal appeal /request for a review of marking to be submitted by a candidate and the outcome known before final marks are submitted to the awarding body

Internal standardisation

Quality assurance (QA) lead/Lead internal verifier

- 85 Ensures that internal standardisation of marks across assessors and teaching groups takes place as required and to sequence
- 86 Supports staff not familiar with the mark scheme (e.g. NQTs, supply staff etc.)
- 87 Ensures accurate internal standardisation - for example by
 - obtaining reference materials at an early stage in the course
 - holding a preliminary trial marking session prior to marking
 - carrying out further trial marking at appropriate points during the marking period
 - after most marking has been completed, holds a further meeting to make final adjustments
 - making final adjustments to marks prior to submission
 - retaining work and evidence of standardisation

Subject teacher

- 88 Indicates on work (or cover sheet) the date of marking
- 89 Marks to common standards

Submission of marks and work for moderation

Subject teacher

- 90 Inputs and submits marks online via the awarding body secure extranet site, keeping a record of the marks submitted to the awarding body deadline
- 91 Ensures checks are made that marks for any additional candidates are submitted and ensures mark input is checked carefully before submission
- 92 Ensures the moderator is provided with authentication of candidates' work, confirmation that internal standardisation has been undertaken and any other subject-specific information where this may be required
- 93 Ensures that for postal moderation the requested sample of candidates' work is securely packaged in bags provided by the awarding body
- 94 moderator label(s) provided by the awarding body are affixed to the package(s)
- 95 Gives the package(s) of candidates' work to the exams officer by the internal deadline

Exams officer

- 96 Submits the requested samples of candidates' work to the awarding body moderator by the external deadline and keeps proof of dispatch on file until the successful issue of final results

Storage and retention of work after submission of marks

Subject teacher

- 97 Keeps a record of names and candidate numbers for candidates whose work was included in the moderation sample
- 98 Retains all marked candidates' work (including any sample returned after moderation) under secure conditions until after the deadline for enquiries about results
- 99 Takes steps to protect any work stored electronically from corruption and has a back-up procedure in place
- 100 Retains evidence of work where retention may be a problem (for example, photos of artefacts etc.)

Exams officer

- 101 Ensures any sample returned after moderation is logged and kept in secure storage for the required retention period

External moderation - feedback

Subject head/lead

- 102 Checks moderator reports and ensures that any remedial action, if necessary, is undertaken before the next examination series

Exams officer

- 103 Accesses or signposts moderator reports to relevant staff
- 104 Takes remedial action, if necessary, where feedback may relate to centre administration

Access arrangements

Subject teacher

- 105 Works with the SENCo to ensure any access arrangements for eligible candidates are applied to assessments

Special educational needs coordinator (SENCo)

- 106 Follows the regulations and guidance in the JCQ publication [Access Arrangements and Reasonable Adjustments](#)
- 107 Where arrangements do not undermine the integrity of the qualification and is the candidate's normal way of working, will ensure access arrangements are in place and awarding body approval, where required, has been obtained prior to assessments taking place
- 108 Makes subject teachers aware of any access arrangements for eligible candidates which need to be applied to assessments
- 109 Works with subject teachers to ensure requirements for access arrangement candidates requiring the support of a facilitator in assessments are met
- 110 Ensures that staff acting as an access arrangement facilitator are fully trained in their role

Special consideration

Subject teacher

- 111 Understands that a candidate may be eligible for special consideration in assessments in certain situations where a candidate
- is absent
 - produces a reduced quantity of work ○ work has been lost
 - Liaises with the exams officer when special consideration may need to be applied for a candidate taking assessments

Exams officer

- 112 Refers to/directs relevant staff to the JCQ publication [*A guide to the special consideration process*](#)
- 113 Where a candidate is eligible, submits an application for special consideration via the awarding body's secure extranet site to the prescribed timescale
- 114 Where application for special consideration via the awarding body's secure extranet site is not applicable, submits the required form to the awarding body to the prescribed timescale
- 115 Keeps required evidence on file to support the application

Malpractice

Head of centre

- 116 Understands the responsibility to immediately report to the relevant awarding body any alleged, suspected or actual incidents of malpractice involving candidates, teachers, invigilators or other administrative staff
- 117 Is familiar with the JCQ publication [*Suspected Malpractice in Examinations and Assessments: Policies and Procedures*](#)
- 118 Ensures that those members of teaching staff involved in the direct supervision of candidates producing non-examination assessment are aware of the potential for malpractice and ensures that teaching staff are reminded that failure to report allegations of malpractice or suspected malpractice constitutes malpractice in itself

Subject teacher

- 119 Is aware of the JCQ [*Notice to Centres - Teachers sharing assessment material and candidates' work*](#)
- 120 Ensures candidates understand the JCQ document [*Information for candidates - non-examination assessments*](#)
- 121 Ensures candidates understand the JCQ document [*Information for candidates - Social Media*](#)
- 122 Escalates and reports any alleged, suspected or actual incidents of malpractice involving candidates to the head of centre

Exams officer

- 123 Signposts the JCQ publication [*Suspected Malpractice in Examinations and Assessments: Policies and Procedures to the head of centre*](#)

124 Signposts the JCQ *Notice to Centres - Teachers sharing assessment material and candidates' work* to subject heads

125 Signposts candidates to the relevant JCQ information for candidates documents

126 Where required, supports the head of centre in investigating and reporting incidents of alleged, suspected or actual malpractice

Enquiries about results

Head of centre

127 Ensures the centre's *internal appeals procedures* clearly detail the procedure to be followed by candidates (or their parents/carers) appealing against a centre decision not to support a clerical check, a review of marking, a review of moderation or an appeal

Subject head/lead

128 Provides relevant support to subject teachers making decisions about enquiries about results

Subject teacher

129 Provides advice and guidance to candidates on their results and the post-results services available

130 Provides the exams officer with the original sample or relevant sample of candidates' work that may be required for an enquiry about results to the internal deadline

131 Supports the exams officer in collecting candidate consent where required

Exams officer

132 Is aware of the individual post-results services available for externally assessed and internally assessed components of non-examination assessments as detailed in the JCQ publication [Post Results Services, Information and guidance for centres](#)

133 Provides/signposts relevant centre staff and candidates to post-results services information

134 Ensures any requests for post-results services that are available to non-examination assessments are submitted online via the awarding body secure extranet site to deadline

135 Collects candidate consent where required

Practical Skills Endorsement for the A Level Sciences designed for use in England

Head of centre

136 Provides a signed declaration as part of the National Centre Number Register Annual Update, that all reasonable steps have been or will be taken to ensure that all candidates at the centre have had, or will have, the opportunity to undertake the prescribed practical activities

137 Ensures new lead teachers undertake the required training provided by the awarding body on the implementation of the practical endorsement

138 Ensures relevant centre staff liaise with all relevant parties in relation to arrangements for and conduct of the monitoring visit

Subject head/lead

139 Confirms understanding of *the Practical Skills Endorsement for the A Level Sciences designed for use in England.*

- 140 Ensures where the centre intends to enter candidates for the first time for one or more of the A level subjects, the relevant awarding body will be contacted at the beginning of the course
- 141 Undertakes training provided by the awarding body on the implementation of the practical endorsement
- 142 Disseminates information to subject teachers ensuring the standards can be applied appropriately
- 143 Liaises with all relevant parties in relation to arrangements for and conduct of the monitoring visit

Subject teacher

- 144 Ensures all the requirements in relation to the endorsement are known and understood
- 145 Ensures the required arrangements for practical activities are in place
- 146 Provides all the required centre records
- 147 Ensures candidates provide the required records
- 148 Provides any required information to the subject lead regarding the monitoring visit
- 149 Assesses candidates using Common Practical Assessment Criteria (CPAC)
- 150 Applies for an exemption where a candidate cannot access the practical endorsement due to a substantial impairment
- 151 Follows the awarding body's instructions for the submission of candidates *Pass* or *Not Classified* assessment outcome

Exams officer

- 152 Follows the awarding body's instructions for the submission of candidates *Pass* or *Not Classified* assessment

Spoken Language Endorsement for GCSE English Language specifications designed for use in England

Head of centre

- 153 Provides a signed declaration as part of the National Centre Number Register Annual Update, that all reasonable steps have been or will be taken to ensure that all candidates at the centre have had, or will have, the opportunity to undertake the Spoken Language endorsement

Quality assurance (QA) lead/Lead internal verifier

- 154 Ensures the appropriate arrangements are in place for internal standardisation of assessments

Subject head/lead

- 155 Confirms understanding of the Spoken Language Endorsement for GCSE English Language specifications designed for use in England
- 156 Ensures the required task setting and task taking instructions are followed by subject teachers
- 157 Ensures subject teachers assess candidates, either live or from recordings, using the common assessment criteria

158 Ensures for monitoring purposes, audio-visual recordings of the presentations of a sample of candidates are provided

Subject teacher

159 Ensures all the requirements in relation to the endorsement are known and understood

160 Follows the required task setting and task taking instructions

161 Assesses candidates, either live or from recordings, using the common assessment criteria

162 Provides audio-visual recordings of the presentations of a sample of candidates for monitoring purposes

163 Follows the awarding body's instructions for the submission of grades (*Pass, Merit, Distinction or Not Classified*) and the storage and submission of recordings

Exams officer

164 Follows the awarding body's instructions for the submission of grades and the storage and submission of recordings
