Remote Learning Agreement for Parents and Students.

- 1 Our on line platforms are monitored, which will provide protection to both staff and students.
- 2 It is advisable for parents and carers to monitor on line behaviour of their children, and set age-appropriate parental controls on digital devices and use internet filters to block malicious websites. These are usually free, but often need to be turned on.
- 3 No lessons, tutorials or meetings should be recorded by parents/carers or students. No should screen shots be taken. Teachers may record lessons and share these with other students for teaching and learning purposes.
- 4 Cameras will be need to be switched off most of the time. This can happen within the Teams area. However, teachers may request cameras to be on for such activities as tutor sessions arranged through school, meetings or examination invigilation. In these situations students should be dressed appropriately (not in nightwear for example) and always be in an appropriate room (not in bed for example) where they can be supervised by an adult.
- 5 Please read the Remote Learning Agreement bullet points below with your child then submit a response to this Agreement by completing the form at the bottom of this document.

Remote Learning Agreement for Students:

- 6 If I am worried about anything at all I will contact school. I can do this by using the Contact Us page on the school website or emailing the school: office@alderbrook.solihull.sch.uk
- 7 My behaviour on line should be as it is during lessons in school.
- 8 I will be respectful towards my teachers and other students at all times.
- 9 I will not copy anything from class charts, school emails, Microsoft Teams or other platforms used by teachers, and place on any other on-line platform or social media.
- 10 I will not record any part of an audio or video call.
- 11 If emailing teachers, I will use my school email only.
- 12 I will maintain the same standards of expectation when using technology at home as I would do in school knowing that all of Microsoft is monitored by school.
- 13 I understand that my teacher may record any live video calls to ensure the safety of all pupils and staff involved.
- 14 If I am involved in a live lesson, I will keep my camera switched off unless the arrangement to have a camera on has been agreed. This will not normally be the case in a class lesson.
- 15 I understand that only the teacher will have the ability to schedule any form of live lesson, and this will be by invite so that the students joining are monitored.
