# Model answer to question 2

At the start of the extract, Dahl presents Mary as being in denial at hearing the news that her husband is leaving her, 'Her first instinct was not to believe any of it...' The use here of the declarative statement reveals to us that Mary's instinct will not accept the news that her husband has told her. She refuses to. It is easier for her to disbelieve the news than to accept that it is true. This feeling of denial is intensified by a further declaration that she is 'going to get supper'. This suggests that she is seeking solace (comfort) in doing routine things: hoping that the truth will not really be real.
